Fama PR Ltd. (service provider) is organizing sightseeing programs for private persons.

The purpose of General terms and conditions is to specify the rights and obligations of the service provider and recipients, as well as to lay down general rules to ensure safety and high level of quality.

General framework of the programes orgnaized by the service provider:

- Pre-registration is required wich can be done individually or as a group.
- Programs are organised by the service provider.
- The duration of programs are between 2,5 and 3,5 hours.

#### I. General terms and conditions

## I.1. Personal scope of terms and conditions

Present policy applies to each individual attending any program organized by the service provider. Each recipient, by attending any program of the service provider considers itself to be bound to the provisions of present document.

# I.2. General conditions of access to service

#### **Prohibitions:**

- -Service may be refused from any individual under the influence of alcohol or any illegal drugs.
- -Recipients attending any program are not allowed to leave the group and the route appointed by the organizers.

### Requirements:

- -Recipients attending any program must follow the instructions of the person in charge of the program delegated by the organizer.
- Recipients attending any program must obey traffic rules.
- Recipients may only use equipment provided by the organizers for their intended purpose.

### Obligations of the service provider:

- -service provider is required to provide all necessary information to recipients before and during the program.
- Service provider is required to provide a group leader in charge of carrying out and coordinating the program.
- I.3. Specific conditions of access to service
- Programs organized by the service provider may only be attended in good physical and health conditions.
- Programs organized by the service provider may only be attended in adequate clothing including shoes. Recipients of service should not wear any clothing that could cause harm or accident while attending the program.

- Programs organized by the service provider can not be attended with any infectious disease.
- I.4. Provisions regarding dangerous objects and substances

The possession and usage of the following objects and substances and the following activities are forbidden during the whole duration of the programs organized by the service provider:

- -Illegal drugs, doping substances and narcotics.
- -Illegal substances or objects (firearms and explosive materials, munitions, pyrotechnic articles)
- -Illegal or immoral activity or behavior and activity that falls outside of the service activity of the service provider.
- Photographing or videotaping without the consent of the Service provider.
- I. 5. Liability rules
- **Equipment may only be used for their intended purpose**. Any advice regarding the usage of the equipment should only be taken from the professional commissioned by the Service provider. The service provider is not responsible for any consequences of taking advice from any other source. (Personal injury, material harm or any other kind of loss or injury)

The service provider is not responsible for any personal injury and damage to property caused by non-intended, improper usage of equipment by the Recipient. The service provider is not responsible furthermore for any injury or loss resulting from behavior that against the law or the regulations of the service provider, or is caused by the behavior of the recipient participating in the program. In such cases the perpetrator of the damage must recover the costs.

Every recipient attending a program organized by the service provider may only do so at own risk and responsibility.

The service provider is not responsible for any damage loss or injury caused by information coming from a third party. In such cases the perpetrator of the damage must recover the costs.

# II. Other provisions

If any person attending the program is behaving against the rules of present terms and conditions, or the person is visibly not suitable to attend the program due to physical or health conditions the person employed by the service provider is authorized to warn the participant about the issue.

In case the warning is unsuccessful, the person employed by the service provider is authorized to ban the person from attending the program.
